



# CSA Palm Harbor | Parks & Recreation 2019 Youth Scholarship Program

CSA Palm Harbor is the entity that manages parks and leisure programs within the unincorporated areas of north Pinellas County. We understand the financial burden on some families in our community to participate in such programs.

In order to provide a structured scholarship program to our participants, applicants must understand that funds are first-come, first-served and may not be available for all programs or activities.

CSAPH offers a 50% scholarship for certain programming. In order to meet the demand for all applicants, the following guidelines apply to all program applications:

- Applicants must reside in the Palm Harbor Fire District.
- Applicants must meet the *Florida Income Eligibility Guidelines* and be on free or reduced-fee lunch with Pinellas County Schools.
- All applications must provide a copy of the most recent IRS W-2 form for any parent(s) or legal guardian(s) in the household.
- Applicants must also include a letter stating financial need.

All materials, along with the completed application form must be turned in to the CSA Palm Harbor administrative offices, located at The Centre, 1500 16<sup>th</sup> Street in Palm Harbor. Items must be in a sealed envelope and addressed to the Scholarship Coordinator. Scholarships are awarded based on need and a first come first serve basis.
